**INSTRUCTIONS for
RETURN OF TANGIBLE PERSONAL PROPERTY – MANUFACTURER (M&T) ONLY [FORM 762M]**

- Section 58.1-3518 of the Code of Virginia requires that all tangible personal property *owned, leased, rented, or borrowed*, as of January 1 of any year, which was used or available for use in a business/profession and which was located in Frederick County must be filed on a personal property return.
- Report machinery & tools used in the manufacturing process.
- Reporting for idle equipment must comply with Section 58.1-3507(D) of the Code of Virginia, which states: "Idle machinery and tools" means machinery and tools that (i) (a) have been discontinued in use continuously for at least one year prior to any tax day or (b) on and after January 1, 2007, have been specifically identified in writing by the taxpayer to the commissioner of the revenue or other assessing official, on or before April 1 of such year, as machinery and tools that the taxpayer intends to withdraw from service not later than the next succeeding tax day and (ii) are not in use on the tax day and no reasonable prospect exists that such machinery and tools will be returned to use during the tax year.

• This form is **DUE annually on or before March 1st** (or first business day thereafter). A 10% or \$2.00 minimum penalty will be imposed if filed after the due date.

- Willful failure to file this return is a criminal offense in violation of Section 58.1-3518 of the Code of Virginia. Taxpayers who are required to file a return but who fail to do so will be subject to a statutory assessment.
- Incomplete forms (e.g., detailed items not listed, all sections not completed, not signed) if not corrected prior to the March 1st deadline will be considered late and a late filing penalty will be imposed.
- Personal property must be reported at the actual cost before any allowance for trade-in. Include personal property which has been expensed or fully depreciated. For idle equipment, see VA Code 58.1-3507, subsection D.
- **Do not** write the words "same as last year" as this constitutes a non-filing and will result in a penalty on your tax billing.
- If **zero** or **none** is listed, an explanation describing how you are able to operate a business without tangible personal property **must** be provided. If it is not, this will constitute a non-filing and will result in a penalty on your tax billing.
- **Do not** include on this form any DMV licensed vehicles, office furniture, computers & computer software, office machines or machinery & tools that are NOT used in the manufacturing process (see forms below).

SECTION A. - OWNED TANGIBLE PERSONAL PROPERTY used in the manufacturing process as of January 1, 2019

Enter the original cost, capitalized or expensed, of all tangible personal property that is **owned** or being paid in installments by the taxpayer. An itemized list or depreciation & amortization schedule [Federal Form 4562] must be provided.

**SECTION B. – LEASED, RENTED, OR BORROWED TANGIBLE PERSONAL PROPERTY
used in the manufacturing process as of January 1, 2019**

For all tangible personal property **leased, rented, or borrowed**, provide the name and address of the owner/lessor, a description of the business personal property, and the beginning and ending dates of the lease, rental, or borrowing.

SECTION C. – TAXPAYER SIGNATURE & INFORMATION

The owner must sign and date this form, and provide the required information in this section even if the form is completed/signed by a paid preparer. If the business is an entity such as an association, partnership, limited liability company, or corporation, it must be signed by a member, partner, executive officer, or other person specifically authorized in writing by the association, partnership, limited liability company, or corporation to sign. Failure to complete this section may result in the return being considered incomplete and a late filing penalty may be assessed accordingly.

SECTION D. – PAID PREPARER SIGNATURE & INFORMATION (if applicable)

If a paid preparer completes the form, he/she must sign, date, and provide the required information in this section.
